**Contracted Use of Reservoir**  
**ACKNOWLEDGEMENT OF RISK AND RELEASE**

Please read this form carefully and be aware that by using the Reservoir as permitted under the terms and conditions of that certain Contract executed by the City of Boulder and BCR for this calendar year, (hereinafter, "the Contract") which Contract permits use of the Reservoir outside of established business hours, you are acknowledging the risk and releasing all claims against the City of Boulder that may arise out of exercising your rights under the Contract. There is a risk of injury associated with use of the Reservoir under the terms of the Contract, such as the following. This list is by no means complete or exclusive, but includes:

1. Heart attack, stroke and circulatory problems,
2. Bone and joint injuries,
3. Back injury,
4. Muscle strain and other muscle injuries,
5. Foot problems,
6. Head, neck, and spinal injuries,
7. Heat stroke or heat exhaustion,
8. Death

As a user of the Reservoir as permitted under the terms and conditions of the Contract I acknowledge that there are certain risks of injury and I agree to assume those risks which I may sustain as a result of participating in any and all activities connected with or associated with using the Reservoir outside of established business hours as permitted under the terms and conditions of the Contract. I further understand that outside of established business hours there are no safety services or city staff available at the Reservoir to respond to an emergency injury and I agree to assume those risks which I may sustain as a result of participating in any and all activities connected with or associated with using the Reservoir outside of established business hours as permitted under the terms and conditions of said Contract. I understand that no persons under the age of 18 years or who have not signed a release shall be on the Reservoir property outside of established business hours.

I further agree to indemnify, hold harmless and defend the City of Boulder and its officers, agents employees and authorized volunteers from any and all claims by other parties resulting from injuries, damages and losses caused by me arising out of, connected with, in any way associated with use of the Reservoir outside of the established business hours as permitted under the terms of the Contract.

I have read and fully understand the above. I understand this agreement shall not be modified orally.
